

**DIRECTIONS TO OUR DES PERES DOCTOR'S OFFICE:**

**FROM HIGHWAY 70:** (Downtown St. Louis, North County, St. Charles County)

TAKE 70 TO HIGHWAY 270 SOUTH. GO SOUTH TO DOUGHERTY FERRY RD (1 EXIT PAST MANCHESTER), MAKE A RIGHT. STAY IN RIGHT LANE AS YOU EXIT 270 AND DOUGHERTY FERRY, TURN RIGHT AT 1<sup>ST</sup> STOPLIGHT. GO TO THE 1<sup>ST</sup> STOP SIGN STATING MEDICAL ARTS BUILDINGS. MAKE A RIGHT AT THE STOP SIGN. WE ARE IN BUILDING 2, BUT THE 1<sup>ST</sup> ON THE LEFT. LOOK FOR BLDG # 2315 AT MAIN ENTRANCE. WALK IN ENTRANCE AND TURN LEFT TO SUITE 103.

**FROM HIGHWAY 40/64** (Downtown St. Louis, Mid County, West County)

Take 40/64 TO HIGHWAY 270 SOUTH. GO SOUTH TO DOUGHERTY FERRY RD. (2<sup>ND</sup> EXIT FROM 40/64). GO TO THE 1<sup>ST</sup> STOPLIGHT AND TURN RIGHT. YOU WILL SEE THE SIGN STATING MEDICAL ARTS BUILDINGS. MAKE A RIGHT AT THE STOP SIGN. WE ARE IN BUILDING 2, BUT THE 1<sup>ST</sup> ON THE LEFT. LOOK FOR BLDG # 2315 AT MAIN ENTRANCE. WALK IN ENTRANCE AND TURN LEFT TO SUITE 103.

**FROM HIGHWAY'S 44 and 55:**

TAKE 44 or 55 to HIGHWAY 270 NORTH. GO NORTH TO DOUGHERTY FERRY RD. (NEXT EXIT NORTH OF HIGHWAY 44/270 INTERCHANGE), MERGE RIGHT OFF THE HIGHWAY AND TO THE STOPLIGHT AT THE TOP OF THE EXIT. MAKE A LEFT (GOING WEST) OVER THE HIGHWAY STAYING IN THE FAR RIGHT HAND LANE. TURN RIGHT AT THE 1<sup>ST</sup> STOPLIGHT. YOU WILL SEE THE SIGN STATING MEDICAL ARTS BUILDINGS. MAKE A RIGHT AT THE STOP SIGN. WE ARE IN BUILDING 2, BUT THE 1<sup>ST</sup> ON THE LEFT. LOOK FOR BLDG # 2315 AT MAIN ENTRANCE. WALK IN ENTRANCE AND TURN LEFT TO SUITE 103.
